Mr. Dancy presided in Mr. Eisenhart's absence and called the meeting to order at 1:45 PM. Mr. Dancy announced that earlier in the day the Board of Trustees met in executive session to discuss real estate, labor relations and personnel matters.

Upon motion by Ms. Fineburg, seconded by Mr. Skiffington, the minutes of the January meeting were approved.

CHAIR'S REPORT

Mr. Dancy reported that planning is well underway for the Foundation Golf Outing in August. Trustees serving on the Golf Committee in addition to Mr. Dancy are Mr. Grupp and Mr. Morris.

PRESIDENT'S REPORT

Dr. Shanblatt announced that Dr. Alexis M. Stranahan was selected by PADE (PA Association for Developmental Education) as the 2014 recipient of the award given to an Outstanding Alumnus of a Developmental Education Program Award. Alexis began her higher education journey at Bucks where she started her math sequence in basic algebra and progressed to college level math. While doing so she learned to manage her math anxiety and also mastered study and time management skills. She successfully completed her courses at Bucks County Community College, transferred to Temple University and completed her doctoral work at Princeton University. Dr. Stranahan completed her postdoctoral work at John Hopkins University, both in

Neuroscience, and is employed today as an assistant professor of physiology at Georgia Regents University in the Medical College of Georgia. Dr. Stranahan serves on the board for three peer reviewed journals and as a reviewer for numerous other publications, as well as reviewing grants in her area of specialty for the National Science Foundation and other agencies. Her research efforts have earned support through three NIH grants in addition to receiving funds from the National Research Council. She is truly an inspiration to developmental education students and living proof of the achievement possible when opportunity and resources are combined with hard work.

The President congratulated the students of the *Centurion* staff for winning an incredible twelve awards! The College student newspaper swept the top category of general news, took the two top spots in public service/enterprise, won best website and layout, and dominated in other categories. This contest, which involves two-year colleges from across the state, shows once again that the *Centurion* is one of the top college papers in Pennsylvania. Great work by all involved. Congrats to our student journalists and their faculty advisor Professor Tony Rogers.

Dr. Shanblatt recognized 471 students whose names appeared on the Fall 2013 President's Honors List. A cumulative GPA of 4.0 is required for the President's Honors list. Congratulations to our hard working students who achieved this recognition.

The President extended thanks to staff members Rhonda Warfield, Mary Kuznicki, Liz Sette and Linda McCann who planned Technology Day which was held on January 10, 2014. This annual event offers a one day immersion opportunity to learn more about new trends in technology.

Dr. Shanblatt reported on the activities of the Engineering Club whose members accompanied Professor Christine Delahanty on a tour of the GRASP lab at the University of Pennsylvania. Faculty and students from MONTCO's quad rotor team were also present. The GRASP lab is a robotics lab where students saw demonstrations involving robots simulating biological forms, quad rotors, and robotics soccer teams and got a firsthand look at where their engineering studies at Bucks can lead them.

The President announced that the College will host a Career Fair on Saturday, March 22, from 11 AM – 2 PM in the Gallagher Room on the Newtown Campus. Sponsored by Representative Michael Fitzpatrick, the fair will be an opportunity for county residents to explore career options and learn more about opportunities at local businesses.

In conclusion, Dr. Shanblatt provided an update to the recent report on Historic Preservation student Clayton Shepherd's work in identifying 32 soldiers buried in unmarked Civil War graves. Clayton is continuing his excellent work by finding descendants, through Ancestry.com, of both Union and Confederate soldiers that he had identified.
