

IMPORTANT INFORMATION FOR LOAN BORROWERS

All new borrowers at Bucks County Community College must complete a new Master Promissory Note (MPN) and Entrance Counseling to receive a Federal Direct Student Loan. Returning borrowers with a prior disbursement will be able to use their active promissory note, but must complete step #3 to receive a loan for the current academic year.

If you are interested in applying for a loan for educational expenses, you will be required to complete the following 3 steps to receive a loan: (returning students that had a prior disbursement only need to complete STEP #3).

Step #1

Complete a Direct Loan Master Promissory Notes (MPN) Loan Application at:

www.studentaid.gov

Step #2

Complete Entrance Counseling. All new student borrowers are required to complete entrance counseling for their loans at:

www.studentaid.gov

If we are able to determine that a returning student has had a prior Federal Stafford Loan, we will not require the completion of the Federal Direct Loan Entrance Counseling.

Step #3

Go to www.MyBucks.edu and log in and access the Financial Aid Tab in Self Service. Once logged in you will be able to Request a Loan (24-48 hours after the Master Promissory Note and Entrance Counseling have been completed). Follow the instructions on the screen to submit your loan request. You can only use the Internet Explorer browser to complete this request. The maximum loan amounts are listed below. You **do not** have to borrow the maximum amount. Request what you need to meet your educational expenses.

PLEASE NOTE: You can only submit one request per year. Students that plan to attend the full academic year (Fall & Spring) should request a **FULL Year** loan amount. If you are not interested in a full year loan you are permitted to complete a Fall only or Spring only request.
