- 2. Deadline(s) to apply: Rolling admission offering six start terms: August, October, January, March, May, and July
- 3. Minimum grade point average (4.0 scale) required: **2.50 GPA** For specific programs: **3.0 for Education major.**
- 4. Do you accept GPA as calculated by previous college or do you re-calculate? **Recalculate if student attended more than one college**
- 5. Maximum number of credits accepted in transfer: 75 credits or 25 courses
- 6. Associate degree required? No Preferred? Yes
- 7. When does the applicant learn which credits will be accepted in transfer? A preliminary (unofficial) transfer evaluations can be completed during the application process. Official transfer evaluations are conducted by an Advising Center once the student is admitted to the University.
- 8. Must SAT or ACT scores be submitted by transfer student? No
- 9. Must high school transcripts or GED be submitted by students with an associate degree? No. For students who have 30 or less college credits, a high school transcript or GED is required.
