## General Information

1. Is on-campus housing available for transfer students? **Yes** Cost? **Total tuition is \$43,344**
2. Full-time tuition: **\$32,098** Part-time tuition: **\$592 per credit** Is evening tuition different? **No**
3. Scholarship availability for transfer students: **Yes. Transfer Awards, PTK, and United Methodist among others. Scholarships range from \$6,000 to \$15,000 annually**
4. Can a transfer student with an associate degree normally expect to receive the baccalaureate degree in two years? **Yes. The only exception to that rule is typically education students.**
5. Can a transfer student complete baccalaureate programs on an evening schedule? **Not on the traditional campus, but in the School of Professional Studies program they can complete a Business Administration program** If so, in what programs?

## Transfer Requirements

1. Best time(s) to apply? **A semester before: September-Spring, January-Fall** Deadline(s): **None, Rolling Admission**
2. What grade point average (4.0 scale) do you consider? **2.0** Prefer? **2.5**
3. If different averages are required for different curricula, please specify: **3.0-Education, 2.8-Social Work**
4. Do you accept GPA as calculated by previous college or do you re-calculate? **Yes, we accept the gpa established by the previous college.**
5. Maximum number of credits accepted in transfer: **72 credits from a 2 year school and 96 from the combination of a 2 year and a 4 year school.**
6. When does the applicant learn which credits will be accepted in transfer? **We will complete an unofficial evaluation before they even apply.**
7. Must the SAT or ACT scores be submitted by transfer students? **Only if a student earned less than 24 credits**
8. Must high school transcripts or GED be submitted by students with an associate degree? **We require that students submit SAT scores and high school transcripts if they have not completed 24 college credits or more. If a student has completed more than 24 college credits, we will only need a copy of their high school diploma.**  
Without the degree but with 30 credits or more? With less than 30 credits?
9. Is the transfer student required to have had the same high school courses (e.g. foreign language, math) as entering freshman? **No**  
If yes, can these be satisfied by college courses? Will these courses also be credited toward the baccalaureate?
10. Are D's transferable? **No** With an AA degree? **No** Without an AA degree? **No** Explain. **The lowest grade we will accept is a C-.**
11. Do you accept Prior Learning Assessment (AP, CLEP, credit by certifications or portfolio, etc.) which may appear on the Bucks transcript? **Yes but we will need an official copy of those scores as well.**
