1. Best time(s) to apply? **anytime** Deadline(s): **PTA program has specific deadlines (Summer term deadline is April 1st, and Winter term deadline is November 1st). OTA program deadlines (Fall term deadline is July 1st, and Spring term deadline is January 1st). All other applications must be received 3 weeks prior to the beginning of the term the student plans to attend.**
2. What grade point average (4.0 scale) do you consider? **2.2+** Prefer? **2.5+**
3. If different averages are required for different curricula, please specify: **PTA/OTA prefer 3.0 GPA**
4. Do you accept GPA as calculated by previous college or do you re-calculate? **Accept college GPA**
5. Maximum number of credits accepted in transfer: **BS 62max, most assoc 38-exceptions: Medical Assisting accepts 31 max, OTA/PTA 36 max**
6. When does the applicant learn which credits will be accepted in transfer? **Typically, once a student applies and provides college transcripts it takes up to 2-3 weeks for transfer evaluation to be completed.**
7. Must the SAT or ACT scores be submitted by transfer students? **No, requested for the PTA/OTA programs only**
8. Must high school transcripts or GED be submitted by students with an associate degree? **Yes**
