Transfer Requirements

1. Minimum admission requirements: **at least 2.0 CGPA**
2. Deadline(s) to apply: **rolling admissions- suggested minimum 2 weeks before term start**
3. Minimum grade point average (4.0 scale) required: **at least 2.0 CGPA Preferred: at least 2.0 CGPA For specific programs: n/a**
4. Do you accept GPA as calculated by previous college or do you re-calculate? **Accept GPA from previous institution**
5. Maximum number of credits accepted in transfer: **75**
6. Associate degree required? **No Preferred? No**
7. When does the applicant learn which credits will be accepted in transfer? **Once all official documents have been received, the Registrar's Office will confirm transfer evaluation. Unofficial evaluations may be done in advance.**
8. Must SAT or ACT scores be submitted by transfer student? **No**
9. Must high school transcripts or GED be submitted by students with an associate degree? **Yes. Unofficial copies accepted**
Without the degree but with 30 credits or more? **Yes. Unofficial copies accepted** With less than 30 credits? **Yes. Unofficial copies accepted**
10. Do you accept Prior Learning Assessment (AP, CLEP, credit by certifications or portfolio, etc.) which may appear on the Bucks transcript? **An official score report from the College Board must be received to earn CLEP credits. Prior Life Assessment (PLA) by portfolio will be assessed by AU after student submits required documentation based on equivalent course requirements. Challenge Exams can also be considered.**
