DUAL ADMISSIONS/INTENT TO ENROLL FORM

Completion of this Dual Admissions *Intent to Enroll* form entitles you to be admitted, upon graduation from a Bucks County Community College’s Associate’s degree program*, into a Bachelor’s degree program at Neumann University provided that you:

1. Complete this *Form* no later than after the successful completion of 45 transferable college-level credits or at least three to six months prior to the start of the semester in which you plan to being studies at Neumann and in accordance with all stipulated Neumann University admission requirements;
2. Graduate from Bucks County Community College with an A.A., A.F.A., A.S. or A.A.S degree with a minimum cumulative GPA of 2.00. [Please be aware that certain majors at Neumann University may require a higher minimum cumulative GPA or specified course-specific grades above a minimum grade of “C”. If you are uncertain about a specific course equivalency or grade requirement at Neumann University, please contact your university’s transfer office];
3. Students who anticipate applying to the **Nursing major** must have all required official documents submitted to the Neumann University Admissions Office by October 15th, **one year prior to enrollment for students wishing to enter in the fall**. Students wishing to enter in the spring semester or summer session must have all required documents submitted to the Neumann University Admissions Office by **April 15th, one year prior to spring enrollment**; and
4. Satisfy all other Neumann University transfer and admission requirements, as listed on pages 1 and 2 of this *Dual Admissions Agreement* and as outlined in the University’s *Undergraduate Catalog*, and provide the required information below.
