- 2. When selecting a College Level Math course, students should choose MATH120
- 3. Choose MKTG100, Principles of Marketing.
- 4. Additional Bucks courses which meet Wilmington requirements include: ECON111, Principles of Economics: Macro, ECON112, Principles of Economics: Micro, and MGMT230, Principles of Management.
- 5. Students may transfer more than 60 credits, but only up to 75. WU has a 45 credit residency requirement.
- 6. The minimum passing grade within the major is C (a grade of C- is not acceptable).
