Trustee virtual attendance was confirmed by roll call.

Mr. Breidinger called the meeting to order at 11:40 AM. He announced that earlier in the day the Board of Trustees met in executive session to discuss real estate, labor relations and personnel matters.

Upon motion by Ms. Shelly, seconded by Ms. Fineburg, the board approved the minutes of the April 2021 meetings.

Mr. Breidinger announced that the opportunity for public comment was available through email at PublicComment@bucks.edu Comments will be shared at the end of the meeting.

## CHAIR'S REPORT

Mr. Breidinger remarked that the month of May is all about celebrating our students and their success during this academic year. On behalf of the entire Board, he expressed appreciation for students' perserverance and flexibility as they adapted to the new virtual learning environment necessitated by the pandemic. He added that the Trustees are looking forward to celebrating and honoring the achievements of the class of 2021 at our drive-through Commencement later this month.

To the retirees for whom, after long careers at Bucks, this is probably a bittersweet time, Mr . Breidinger expressed the thanks of the Board for their service to our students and to the college and wished them all the best in the next phase of their life.

## PRESIDENT'S REPORT

The President reported that the Student Research Conference was held on Friday, April $30^{\text {th }}$ and consisted of 189 students presenting on various course topics in seven panel sessions. The college-wide event was held on Zoom for the second semester and saw its numbers almost double from the fall event. Special thanks to Professors Charlie Groth and Sarah Bruck for organizing the event, along with all of the faculty and staff who volunteered to help make the Conference a success.

Dr. Shanblatt announced that the High School Poet of the Year Contest virtual Reading + Reception will take place on Sunday, May 16 1-2:30 pm on the Bucks YouTube channel. The judges reviewed over 150 entries this year with many outstanding entries. Please plan to check out the outstanding high school poets in the county. Finalist and winners will be reading from their work.

President Shanblatt shared news that the Language \& Literature Department, in collaboration with the STEM Department and the Academic Success Center, is launching a new Summer Bridge Program during Summer Session III. The program is designed to support the transition to college by providing students with the academic skills and social resources needed to succeed in a college environment. The Program will allow students to get a head-start on their academic coursework in a 7 -week program at the Newtown Campus. Scholarships opportunities are available, including free tuition for a limited number of rising seniors. Information can be found on the Language \& Literature website - www.bucks.edu/summer-bridge. Sincere thanks to the faculty and staff who worked together to provide this outstanding opportunity for our future students.

Dr. Shanblatt congratulated the Foundation for raising more than $\$ 80,000$ collectively, in supports of scholarships, student emergency grants and the adult basic education program, through its Pour it Forward virtual tea "room" (in lieu of the Salute to Mothers Scholarship Tea) and the Bashing Barriers campaign. Thanks to all supporters of this effort to ease the many burdens faced by our students. There is still time to support both.

The President extended congratulations to the alumni recognized this year for their professional achievements that advance the mission of the college and benefit the greater community. The four alumni recognized for their achievements with an Alumni Association Award are: Dr. Karen Holt, Steven Kaplan, Anna Payne, and Alvin Ayensu. Their bios can be viewed at bucks.edu/alumni and they will be featured as part of commencement pre-show video.

Dr. Shanblatt reviewed the the Associate Degree Nursing Poster Presentation which brought a total of 73 topics related to the COVID-19 pandemic to both college and the Bucks County Community with invitation to our clinical sites. Thanks to Connie Corrigan and Jim Sell for getting the word out on the great work done by LPN students and faculty who assisted with vaccinations at Lower Bucks Hospital last month. The story was featured in Levittown Now and the Bucks contribution to the vaccination effort was publicly recognized at a recent Lower Bucks hospital board meeting. Thanks to all who facilitated this great effort which once again demonstrated that Bucks is the community's college.

In conclusion, the President noted that the college hosted the Virtual Program for Holocaust Remembrance, The Jews of Manila which explored the story of the program in the Philippines to find refuge for Jews oppressed by the Nazis, divert them from being sent to concentration camps in Europe and bring them to safety in Manila. On Friday May 7, 2021, Kevin Antoine CDEIO was appointed the board of directors of the United Way of Bucks County. Congratulations to Kevin for his work in the community on behalf of the college.

However, due to the fact that I do not have a green card, I am not able to qualify for in county or even in state tuition at Bucks . Penn State, the University that I do attend, does consider me to be in state but Bucks County, the college in the County that I graduated High School from, does not. Under the current BCCC policies, immigrant children who have been living in the US legally are unable to qualify for in state tuition. I am aware this is not an issue that is widely talked about, but it is one that affects me greatly. Therefore, I would greatly appreciate it, if BCCC could recognize the hard working, legal residents of this community and provide some sort of change, so that children like me have access to more affordable education.
