Below are listed additions and corrections to the 2022-23 Bucks County Community College Catalog since its publication. All corrections listed below have been made in the main online catalog sections to which they apply. They do not appear, however, in the PDF version of the full catalog.

SECTION 2: MAJORS AND CERTIFICATE PROGRAMS

Health Information Technology, Associate of Arts (Curriculum Code No. 2191): The program's learning goals have been updated to include:

HITT280-the clinical externship- is scheduled Monday through Friday during the day. There are no weekend or evening clinical site hours. Students must complete a total of 120 hours, with a minimum threeday-a-week availability recommended. Prior to Externship placement, students must submit (at their own expense):

- Requests for federal and state background checks •

- Certification of Health Status
- Certification in CPR: Health Care Provider (AHA-BLS)
- A mandatory 10-panel expanded opiates drug screen to be completed no sooner than 30 days • before the start of the externship.

Medical Administrative Specialist, Certificate Program (Curriculum Code No. 3148): The program's learning goals have been updated to include:

Students must complete a total of 160 hours, with a minimum three-day-a-week availability recommended. Prior to Externship placement, students must submit (at their own expense):

Meeting, Convention, and Event Planning, Certificate Program (Curriculum Code No. 3172): This certificate program has been deactivated.

Music, Associate of Music (Curriculum Code No. 1019): The program's goals have been updated:

"The Music major, which is designed to prepare students for transfer in Music to four-year institutions, is a curriculum that culminates in an Associate of Music degree. Numerous courses in the program fulfill

Core Curriculum requirements for general students, and students enrolled in other majors are encouraged to participate in any course or performing ensemble for which they qualify.

Graduates of this program are able to:

- perform musical repertoire in both solo and ensemble environments;
- analyze in both written and aural formats the historical forms, styles, genres, and compositional techniques of varied musical repertoire;
- analyze diatonic and chromatic harmonies;
- construct diatonic and chromatic harmonies;
- sight-sing melodies;
- notate musical dictation; and
- employ music technology productively in both practical and creative contexts."
