## PARKING MAP

To assure that our driver situates the vehicle correctly, we ask that you complete a parking map.

**Re-positioning the trailer will result in an additional charge and the loss of one day in the schedule.**

Therefore it is critical that parking details be clear and arranged in advance. When determining where Artmobile should be placed on your site, please meet the following requirements:

- An area of at least 60' x 20' and within 100 feet of a suitable electric line is required. The trailer is 48' long and 10' is needed at the rear to operate the lift.
- Our driver must have ample space in which to maneuver his vehicle.
- A minimum of 4 feet is needed along the right side of the trailer for the steps.
- The steps must be installed on level ground. It is not possible to park the trailer along a curb and to install the steps on the sidewalk.
- Keep in mind the safety of your visitors as they enter and exit the trailer.

## ARRIVAL

Artmobile will be delivered to your site between \_\_\_\_\_ and \_\_\_\_\_

## SET-UP

An Artmobile staff person will arrive at **8:30 a.m.** on \_\_\_\_\_ to set up. Brief assistance from **two** of your staff is required at this time to assemble the stairways. Your staff's assistance is also required at closing to disassemble the stairways.

## ELECTRICITY

Artmobile requires: 120/208 voltage, single phase, 100 amp service. The cable is 100' long and not equipped with a plug. Your electrician is required by **8:30 a.m.** on \_\_\_\_\_ to connect the Artmobile to your power supply. All electrical connections are on the exterior of the trailer. Any delay in the electrician's arrival to connect the Artmobile will adversely effect the start of classes. **For the safety and security of the art exhibited, Artmobile must have electrical power at all times, including overnight and weekends.** The cable may be fastened along the top of the trailer for the safety of visitors. If the cable is placed on the ground across a driveway, it must be positioned between two 2" x 4" boards in order to protect the cable from passing vehicles.

Your electrician is also required to disconnect the Artmobile by \_\_\_\_\_ on \_\_\_\_\_. The cable must be rewound and securely tied on the reel. Failure to disconnect Artmobile properly and at the specified time results in additional transportation cost which will be passed on to your organization.

### GROUP or CLASS SCHEDULING

If your site has arranged groups or classes to visit Artmobile, please fill out the class schedule with times and number of adults and children. No more than 25 visitors can be accommodated at one time. Groups may be scheduled for 45 to 60 minute sessions. Make sure to include starting and ending times of the classes as well as age groups on the schedule. Allow for at least a 30-minute lunch break. Mail your class schedule to Artmobile at least three weeks before the tour visit and retain a copy for us upon arrival.

On the closing day, classes or groups must end **one hour before closing** to allow time for other visitors and packing the trailer before electricity is disconnected.

### PAYMENT
