COURSE OFFERINGS 16 HOUR CLASSES SATURDAY AND SUNDAY OCTOBER 22-23, 2022

PUMP OPERATIONS I (PUOP)

FSC 420 009

PREREQUISITES: IST OR INTRODUCTION TO THE FIRE SERVICE AND 18 YEARS OF AGE FIRST DAY OF CLASS

This course provides the fire fighter with an introduction to basic pump construction and theory as well as operating techniques. Emphasis is placed on getting water to the pump, getting water from the pump to hose lines, and prevention of common mistakes in pump operations.

GEAR: TURN OUT GEAR

PUMP OPERATIONS II (PUOA)

FSC 421.009

PREREQUISITES: PUOP AND MUST BE 18 YEARS OF AGE FIRST DAY OF CLASS

This course is designed to instruct the student in advanced techniques of operating pumps. Topics covered include friction loss, relay pumping, master streams and elevated master streams

GEAR: TURN OUT GEAR

ENGINE COMPANY OPERATIONS (ECOP)

FSC 205.009

PREREQUISITES: EBM OR INTERIOR FIRE FIGHTING OR FF-1 CERT.

MUST BE 18 YEARS OF AGE. GEAR: TURN OUT GEAR, SCBA

This course provides instruction in the duties and responsibilities of an engine company. Topics include: fire behavior and spread in structures, positioning of apparatus, use of attack and backup lines, search and rescue, and water supply. A series of hands-on drills involving various engine company evolutions follows the classroom discussion.

TRUCK COMPANY OPERATIONS I (TRCO)

FSC 209,009

PREREQUISITES: EBM OR EQUIVILANT / TRUCK 1

MUST BE 18 YEARS OF AGE. GEAR: TURN OUT GEAR, SCBA

The student will be introduced to the basic concept of truck company operations as part of an organized, coordinated structural fire suppression operation. Truck companies, regardless of whether they arrive on an aerial device, squad, or engine, are the 'combat engineers' of fire attack operations. This course, for experienced fire fighters, will introduce the student to the basic concept of truck company operations and duties, including organizing the delivery of truck company services, selection and use of key tools, advanced ventilation and forcible entry theory and practices, search and rescue, and other fire attack support functions.

SCBA BOOTCAMP

FSC 0307.009

PREREQUISITES: IST OR INTRODUCTION TO THE FIRE SERVICE AND 18 YEARS OF AGE FIRST DAY OF CLASS

GEAR: TURN OUT GEAR / SCBA / SPARE CYLINDER

Designed for the skilled firefighter, this course will enforce skills and challenge firefighters in the rigors of utilizing their self-contained breathing apparatus (SCBA) during interior structural firefighting. The students will be presented with various scenarios which are encountered in the firefighting environment, such as 'low air' air management and SCBA emergencies. The student will engage in intensive situations which will serve as a proficiency self-evaluation of their capabilities of SCBA use in structural firefighting. The veteran firefighter, not to be feeling left out, will be pushed to challenge the limits of their skill set in real world examples of SCBA use and structural firefighting challenges.

INTRODUCTION TO THE FIRE SERVICE (ELIS)

FSC 2459 009

PREREQUISITES: MUST BE 14 YEARS OF AGE BY FIRST DAY OF CLASS

GEAR: TURN OUT GEAR

This entry level course is designed to introduce new firefighters to basic information including an overview of the fire service, fire service organization, firefighter safety, personal protective equipment, tools and emergency lighting, and backing apparatus. This is the first of five levels (courses) in the curriculum

BASIC FIRE POLICE (BFPO)

FSC 0604.009 MUST BE 18 YEARS OF AGE OR OLDER

GEAR: NONE

This course provides instruction on the proper method to be appointed, the laws pertaining to fire police, fire police powers, and the expected duties of a new fire police officer.

Bus Rescue

FSC 0238.009 MUST BE 18 YEARS OF AGE OR OLDER

GEAR: TURN OUT GEAR

This course challenges the vehicle extrication technician to solve safety, stabilization, and patient care problems encountered at motor vehicle accidents involving buses. This advanced level course allows the students to size-up an incident, determine the best response action, evaluate resources (accessible and usable), execute an action plan, consider and select MCI resources, and evaluate patient care and extrication processes. Through scenario based exercises, the student will apply learned knowledge and skills needed to ensure rescue team effectiveness in a safe and efficient manner.

COURSE OFFERINGS

Fire Fighter Survival

FSC 0202.009 MUST BE 18 YEARS OF AGE OR OLDER

GEAR: TURN OUT GEAR

This program is a physically demanding, comprehensive program dealing with the necessary knowledge and skills relative to rescue procedures needed for self rescue. Emphasis will be placed on search techniques, communications, accountability/location and self rescue procedures. This program will teach the firefighters how to reduce the risk of fire fighter injuries and deaths in Pennsylvania. The class will enable fire fighters to become more aware and familiar with procedures that may be used to prevent or perhaps lessen the seriousness of injuries or even save their lives. Students must be in adequate physical condition to perform 100% of all practical exercises.

Basic Rescue Task Force FSC 0724.009

This course is designed to introduce EMS, fire, and law enforcement to the rescue task force concept as it pertains to responding to active shooter scenarios or acts of aggressive deadly behavior. This two day course is will train responders personal safety, life-saving techniques, provider/patient movement, triage, and other important aspects of the concept. This concept allows EMS and fire to be partnered with law enforcement officers to enter secured areas and utilize their training to treat/transport injured individuals. This course offers both classroom and realistic scenario based exercises.

Vehicle Fires and Other Emergencies FSC 0308.009

This course is designed to introduce EMS, fire, and law enforcement to the rescue task force concept as it pertains to responding to active shooter scenarios or acts of aggressive deadly behavior. This two day course is will train responders personal safety, life-saving techniques, provider/patient movement, triage, and other important aspects of the concept. This concept allows EMS and fire to be partnered with law enforcement officers to enter secured areas and utilize their training to treat/transport injured individuals. This course offers both classroom and realistic scenario based exercises.

IMPORTANT PLEASE READ COURSE PREREQUISITE INFORMATION

Courses that have no prerequisite requirements are considered entry level and do not require any prior knowledge of the subject matter of the course. Courses that require prerequisites are advanced level training designed to build on the student's prior knowledge of a subject. Prerequisites are <u>REQUIRED</u> for a particular course to ensure that the student has a basic understanding of the knowledge and skills that are necessary to complete the requirements of a course. When a chief or supervisor signs the authorization for a student to attend a class, he or she is attesting that the student has the background necessary to complete the requirements of the course. Students must complete all requirements of a class in order to receive a certificate.

STUDENTS REGISTERING FOR COURSES WHICH HAVE PREREQUISITE REQUIREMENTS WILL BE REQUIRED TO BRING COPIES OF THEIR CERTIFICATES TO CLASS ON SATURDAY MORNING. INSTRUCTORS WILL VERIFY THAT THE STUDENT IS QUALIFIED TO ATTEND THE COURSE.

PRE-REGISTRATION INFORMATION

PRE-REGISTRATION DEADLINE IS OCTOBER 10, 2022

Applicants must be the posted years of age or older by the first date of class. All students must be authorized by their chief or supervisor to attend. Junior fire fighters may not enroll in any course which involves live fire or live fire smoke. The Pennsylvania State Fire Academy policy on facial hair will be strictly enforced.

REGISTRATIONS FOR ALL COURSES WILL BE HANDLED BY BUCKS COUNTY COMMUNITY COLLEGE, YOUR EDUCATIONAL PROVIDER. The basic fee for the MAMA Emergency Services Training Weekend is \$70.00 which includes facilities, expendable materials costs, lunch and refreshments both days.

ALL REGISTRATIONS MUST BE ACCOMPANIED BY A CHECK OR MONEY ORDER DRAWN TO B.C.C.C. OR A CREDIT CARD ACCOUNT NUMBER (MUST INCLUDE 3 DIGIT V CODE) OR COMPANY/DEPARTMENT PURCHASE ORDER NUMBER.

Students who register for the <u>FLASHOVER SIMULATOR</u> are required to pay an additional \$65.00 lab fee (\$135.00 total). Students who register for the <u>BUS_RESCUE</u> are required to pay an additional \$30.00 lab fee (\$100.00 total).

No telephone registrations will be accepted. Pre-registration is necessary and should be done EARLY. Class sizes are limited in number and are filled on a first come basis. Students are requested to select up to three of the two day seminars in order of priority. Applicants should only select courses that they desire to be enrolled in. ANY COURSE MAY BE CANCELLED DUE TO INSUFFICIENT ENROLLMENT OR OTHER CIRCUMSTANCES.

In case of course cancellation or if a course is filled, students are automatically placed in the next class choice indicated on the registration form. If another choice is not indicated on the form, the student's registration fee will be returned. Students will be notified of course cancellations or any other changes as soon as possible.
