1. Best time(s) to apply? **Rolling admissions** Deadline(s): Recommended by March 1<sup>st</sup> for the fall semester, but will still be accepted afterwards
2. What grade point average (4.0 scale) do you consider? **Depends on Program** Prefer?
3. If different averages are required for different curricula, please specify: **Yes, Nursing students have to have a 3.0 GPA or higher (pre-requisite courses required as well)/ Education students need to have a 2.75 GPA or higher/ Pre-Professional Program students need to have a 2.5 or higher/ Liberal Arts and Business students need to have a 2.0 GPA or higher.**
4. Do you accept GPA as calculated by previous college or do you re-calculate? **Re-calculate GPA**
5. Maximum number of credits accepted in transfer: **90 transfer credits**
6. When does the applicant learn which credits will be accepted in transfer? **Once accepted the student will receive a transfer credit evaluation.**
7. Must the SAT or ACT scores be submitted by transfer students? **No, as long as the student has been out of HS for more than 1 yr.**
8. Must high school transcripts or GED be submitted by students with an associate degree? **No**  
Without the degree but with 30 credits or more? **No** With less than 30 credits? **Less than 24 credits, a student will need to submit high school transcript.**
9. Is the transfer student required to have had the same high school courses (e.g. foreign language, math) as entering freshman?  
If yes, can these be satisfied by college courses? Will these courses also be credited toward the baccalaureate?
10. Are D's transferable? With an AA degree? **Not as part of the major.** Without an AA degree? **No** Explain.
11. Do you accept Prior Learning Assessment (AP, CLEP, credit by certifications or portfolio, etc.) which may appear on the Bucks transcript? **CLEP exams may be accepted.**
