4. Do you accept GPA accepted as calculated by previous college or do you re-calculate? **Accept as calculated by previous college, but will calculate a cumulative GPA if attended more than one institution.**
5. Maximum number of credits accepted in transfer: **90 credits towards a Bachelor's degree, 30 towards an Associate's degree**
6. When does the applicant learn which credits will be accepted in transfer? **Students can request a preliminary transfer credit evaluation prior to applying by emailing prelimeval@snhu.edu or wait to receive the official evaluation with the acceptance letter.**
7. Must SAT or ACT scores be submitted by transfer students? **No.**
8. Must the H.S. transcript or GED be submitted by the student with an associates degree? **No.**
