2. Format options: **eight week sessions (six per year)**
3. Class Times/Schedule: **Classes meet once a week. Most students do two classes per session. Evening classes meet from 5:30 pm -10:00 pm. Saturdays 8:15 am – 12:45 pm or 1:00 pm -5:30 pm**
4. Other class options (time/format) for accelerated students:
5. Shortest timeframe to complete a bachelor's degree: **Students who come with an Associate's Degree can complete in about 18 months.**
6. Maximum number of credits that may be taken in one semester/term/year: **12 credits per semester, 36 credits per year. Students who have a GPA of 3.0 or higher may do as many as 18 credits per semester.**
7. Full-time tuition: Part-time tuition: **\$490.00 per credit**

3. Do you accept GPA as calculated by previous college or do you re-calculate? **Previous college**
4. Maximum number of credits accepted in transfer: **75**
5. Associate degree required? **No** Preferred?
6. When does the applicant learn which credits will be accepted in transfer? **As soon as we received an official transcript for an applicant, that student receives an official evaluation. Unofficial evaluations can be done on the spot by an admission counselor.**
7. Must SAT or ACT scores be submitted by transfer student? **No.**

8. Must high school transcripts or GED be submitted by students with an associate degree? No
Without the degree but with 30 credits or more? **No** With less than 30 credits? **Yes**
9. Do you accept Prior Learning Assessment (AP, CLEP, credit by certifications or portfolio, etc.) which may appear on the Bucks transcript? **We do accept Prior Learning Assessment but we require the original documents just as we would for credits that might transfer to Bucks from another college.**
