**General Information**

1. Available baccalaureate programs: **Business Administration, Computer and Information Systems, Networking and Communications, Multimedia and Web Design, Game and Simulation Programming, Health Care Administration, Electronics Engineering Technology, Computer Engineering Technology, Biomedical Engineering Technology, plus Technical Management and Management (degree completion programs).**

2. Format options: **Online, onsite or mix-and-match. All accelerated formats.**

3. Class Times/Schedule: **Morning, Afternoon and evening.**

4. Other class options (time/format) for accelerated students:

5. Shortest timeframe to complete a bachelor's degree: **3 years, 4 months (for all 124 credits)**

6. Maximum number of credits that may be taken in one semester/term/year: **10 per session or 60 per year.**

**Transfer Requirements**

1. Minimum admission requirements: **2.0 with qualifying test scores and/or prior coursework in English and Math.**

2. Deadline(s) to apply: **NA. Rolling admissions.**

3. Minimum grade point average (4.0 scale) required: **(See #1)** Preferred: **2.8 GPA.** For specific programs:

4. Do you accept GPA as calculated by previous college or do you re-calculate? **Do not recalculate.**

5. Maximum number of credits accepted in transfer: **92**

6. Associate degree required? **No** Preferred? **No, but scholarships may apply to those with associate's degree.**

7. When does the applicant learn which credits will be accepted in transfer? **Normally within 48 hours after submitting transcript.**  
**Transfer credit is reviewed at no cost to student.**

8. Must SAT or ACT scores be submitted by transfer student? **No. Students may be required to take DeVry's entrance exam depending upon prior coursework and gpa.**

9. Must high school transcripts or GED be submitted by students with an associate degree? **No.**

Without the degree but with 30 credits or more? **YES** With less than 30 credits? **YES**

10. Do you accept Prior Learning Assessment (AP, CLEP, credit by certifications or portfolio, etc.) which may appear on the Bucks transcript? **Yes – AP and CLEP only: must provide test results.**
